2023/24-02-103/ Vega, Andrade-Dominguez – Resolution in Support of Student Parents

Moved and seconded. This resolution is in support of student parents at Sacramento State. It was shared how many students on campus identify as student parents and how this resolution aligns with the Board strategic priority. The resolution was read in its entirety. Adopted.

2023/24-02-104/ Baraiya – Allocation of Funds for Peak Adventures Transportation Vans

Moved and seconded. Context was provided on the current vans utilized for transportation by Peak Adventures as well as the state of these vans. The costs associated with obtaining commercial licenses were shared as the vehicles currently being operated require this license due to the vehicles have 12 passenger capacities. It was added that while the purchase of 10 passenger vehicles would reduce the number of students that would be able to attend trips offered by Peak Adventures the goal is to increase the fleet on hand. Further this would allow for the costs associated with trips to stay steady, as these vehicles do not require a commercial license. The purpose and financial impact of this legislation were shared. Adopted.

2023/24-02-105/ Torres, Baraiya, Andrade-Dominguez –Allocation of Additional Alternative Transportation Funds for Peak Adventures Bike Discount Program Moved and seconded. Moved to amend the impact of the legislation to state release of up to \$15,000 from the alternative transportation fund for the bike discount program leaving a remainder of \$71,000 instead of allocating up to \$15,000. Adopted. Moved to amend the sentence stating with additional funding this discount program can last through the summer and possibly fall to with additional funding this discount program will begin Spring 2024 and can last through the summer and possibly fall. Adopted. Back to original motion. Adopted with amendments.
