2023/24-03-125/ Aguirre, Escalante, Ambaliya, Baraiya – Allocation of Strategic Priority funding for 2.2.2 – Collaborate and Promote Campus Partners' Initiatives and/or Activities for Professional Development

Moved and seconded. The legislation was read in its entirety and it was shared that this opportunity came about as a professor contacted the Director of Education to conduct this event. The requested amount was increased from up to \$800 to up to \$1000. The logistics of the event were shared. Adopted.

2023/24-03-126/ Baraiya, Andrade-Dominguez – Operating Rule Change – 600.1 General Policies

Moved and seconded. It was shared that specific policies need to be updated as they were last updated in 2017. Discussion was had on the importance of these updates given the nature of the how Board members change on a yearly basis and additionally at the current moment those responsibilities are being completed by a staff member, not a Board member and therefore the policies should reflect that. Adopted.

2023/24-03-127/ Baraiya, Andrade-Dominguez – March 2024 ASI Financial Policy Manual Updates

Moved and seconded. These policies have not been updated in major ways since 2017. A lot of changes have occurred across CSUs since then and these updates will allow the organization to align with current CSU policies some of which include new travel requirements and hospitality policies. These updates will also ensure that ASI as a department has their own policies. This legislation went through ASI Management Work Team (MWT) and ASI Finance and Budget Committee so feedback has been provided by multiple individuals. Adopted.

Moved and seconded. The funding requested was updated from up to \$725 to up to \$750. Adopted.
