VI. Discussion Items:

- a. AB 1790 (Connolly) California State University: sexual harassment: implementing California State Auditor recommendations.
 - i. *This bill would require the CSU to implement the recommendations provided in a specified California State Auditor report, as provided. The bill would require the CSU to submit an initial report and a final report to the Legislature on the status of implementing the California State Auditor recommendations including summarized results from specific campus compliance reviews and identification of any systemic issues the CSU needs to address in its progress towards taking corrective action.*

- b. AB 1793 (Ta) Student financial aid: Cal Grants: Middle Class Scholarship Program: eligibility: dependents of members of the armed services stationed outside of California.
 - i. *This bill would extend Cal Grant and Middle-Class Scholarship Program eligibility to a student who was not a resident of California at the time of high school graduation or its equivalent but meets all other applicable*

- d. AB 2093 (Santiago, Cervantes) Community colleges: California College

Promise: fee waiver eligibility and funding formula.

- i. This bill would extend the term of eligibility of the California College Promise Grant for an additional 2 academic years for first-time community college students and returning community college students who matriculate into upper division coursework of a community college baccalaureate degree program.*

- e. SB 307 (Ashby, McGuire) Middle Class Scholarship Program: community colleges: current and former foster youth.

- i. This bill would extend awards under the MCSP to community college students who are current or former foster youth pursuing transfer to a 4-*
